Acceptance of the Privacy Policy

In cases where we seek your consent to process your personal data, we will explicitly ask for your approval before collecting, using, or disclosing your information.

Personal Information We Collect

When you create an account with Daman, we collect both personal and non-personal information to verify your identity and comply with relevant laws, including Anti-Money Laundering (AML) and Counter-Terrorism Financing (CFT) regulations.

The information we collect includes, but is not limited to:

- **Personal Information:** Full name, email address, phone number, proof of identity (passport, ID), residential address, and bank details.
- **Financial Information:** Bank account details, source of funds, and other documents that verify the source of funds.
- **Non-Personal Information:** Device and browser information, IP address, location data, log-in details, and analytics related to your interactions with our platform.

Use and Disclosure of Your Personal Information

The personal information you provide allows Daman to offer you secure and personalised experience. We use this information to:

- Verify your identity for account creation and regulatory compliance.
- Facilitate transactions, including virtual asset purchases and settlements.
- Enhance your experience by analysing website traffic and improving platform features.
- Communicate important notices about changes to our services, terms of use, and security updates.

Daman will never sell or share your personal information with third parties for profit. We may, however, disclose your information to government or regulatory authorities if required by law, or if necessary to protect our legal rights or comply with legal obligations.

Storage of Personal Information

Your data is stored securely on servers located in the UAE. Daman may utilise third-party service providers to store and process your information, but these providers are obligated to protect your data in line with our standards. Personal information is retained for a minimum of 10 years following the closure of your account, in compliance with regulatory requirements.

Data Owner Rights

As a client, you have several rights regarding your personal data, including the right to:

- Access: Request details about the personal information we hold about you.
- Rectification: Request the correction of inaccurate or incomplete data.
- Erasure: Request the deletion of your personal information under certain conditions.
- Objection: Opt-out of receiving marketing communications or having your data processed for certain purposes.
- Withdraw Consent: Withdraw your consent to data processing at any time, with future effect. Please note that withdrawing consent may affect your ability to use our services.

Account Closure

Upon request to close your account, Daman will deactivate your account and retain your personal information for a minimum of 10 years as required by applicable laws. This retention period ensures we can comply with our legal obligations, such as fraud prevention, regulatory compliance, and dispute resolution.
